Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	In-network: \$2,600/\$5,200 (individual/family-\$2,600 per family member). Out-of-network: No coverage.	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family deductible.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> services are covered before you meet your deductible.	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain preventive services without <a href="#">cost-sharing</a> and before you meet your deductible. What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	In-network: \$4,600/\$9,200 (individual/family-\$4,600 per family member). Out-of-network: No coverage.	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services.
