Important Questions	Answers	Why This Matters:
What is the overall deductible?	In-network: \$2,600/\$5,200 (individual/family- \$2,600 per family member). Out-of-network: \$5,200/\$10,400 (individual/family).	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> services are covered before you meet your deductible.
